ORDINANCE NO.: 2023-076

*Approval for Granting an Easement to Dominion Energy South Carolina, Inc. along a Portion of City-Owned Property Located at 1735 Roslyn Drive and Identified as Richland County TMS#13911-06-08 for the Installation of Overhead Electric Lines as requested by the City of Columbia for the Penn Branch Storm Drainage Improvements Project; SD8371; CF#250-613*

WHEREAS, Dominion Energy South Carolina, Inc. has made a request for an easement along the subject City-owned property for construction and relocation of overhead electric lines and appurtenances near Penn Branch and located on Richland County TMS#13911-06-08; and,

WHEREAS, the relocation plans for the overhead electric lines and appurtenances have been reviewed and approved by the Department of Engineering and there are no conflicts with existing utilities or planned City utilities on the subject property; NOW, THEREFORE,

BE IT ORDAINED by the Mayor and City Council of the City of Columbia, South Carolina this 18<sup>th</sup> day of July, 2023, for and in consideration of the sum of One and No/100 (\$1.00) Dollar, each to the other paid, the City Manager is hereby authorized to execute an easement on behalf of the City of Columbia to **DOMINION ENERGY SOUTH CAROLINA, INC.** for ingress, egress, installation and maintenance of overhead electric lines and appurtenances along the subject property.


The referenced easement is shown on drawing #E181494 prepared by Dominion Energy South Carolina, Inc. for Overhead Electric Lines for St. Claire – Pole Relocation, dated February 28, 2023, sheet 1 of 1, and being on file in the office of the Department of Engineering, City of Columbia, South Carolina under City file reference #250-613. A copy of said drawing being attached hereto and made a part hereof as Exhibit "A".

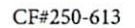
