

RESOLUTION NO.: R-2022-026

Approval for Release and Abandonment of City of Columbia Sewer Easements for CIP Project# SS7261 (Lake Katherine Sewer Line Capacity Enhancement Project); Richland County TMS#13816-01-20, 13915-11-44, 13816-01-21, 13913-05-22, 13913-05-20, 13913-05-19, 13913-05-18, 13913-05-09, 13914-02-04, 13913-02-03, 13914-02-02, 13911-03-17, 13914-01-01; CF#250-378

WHEREAS, the City of Columbia obtained a new permanent sewer easement from the owners of the subject properties for CIP Project# SS7261 described as the Lake Katherine Sewer Line Capacity Enhancement Project; and

WHEREAS, the construction plans for CIP Project# SS7261 have been changed to move the proposed sanitary sewer construction to another location on the subject property. An easement has been granted by the owners in the new location; and

WHEREAS, a request has been made for release and abandonment of the original sewer easements granted to the City on the subject property that are no longer necessary; NOW, THEREFORE,

BE IT RESOLVED by the Mayor and City Council this 5th day of April, 2022, for and in consideration of the sum of One (\$1.00) Dollar, each to the other paid, and the granting of a sewer easement to the City of Columbia, the receipt of which are hereby acknowledged, the City Manager is hereby authorized to execute a release and abandonment instrument from the City of Columbia that remises, releases and forever quitclaims unto the herein-below named property owners, their heirs, personal representatives, successors and assigns, that portion of the City of Columbia's existing permanent sewer easements along the subject properties, being more clearly shown on drawings for CIP Project #SS7261, dated July 8, 2021 and being attached hereto and made a part hereof as Exhibit "A".

Said drawing also being on file in the Department of Engineering under file reference #250-378.
