Authorizing the Award of a Grant in the amount of Eighty Thousand (\$80,000.00) Dollars to Richland County School District One for the Jobs for America's Graduates ("JAG-SC") Program and authorizing the City Manager to execute a Service Contract Agreement implementing that Grant

BE IT RESOLVED by the Mayor and City Council this 20<sup>th</sup> day of December, 2022, that the City of Columbia hereby grants up to Eighty Thousand and No/100 (\$80,000.00) Dollars in support of the Richland School District One's Jobs for America's Graduates ("JAG-SC") Program whereby up to Ten Thousand and No/100 (\$10,000.00) Dollars will be allocated to each of eight schools in the District for the purpose of empowering District One students with the skills and support needed to succeed in education, employment and life. The City's contribution is to be matched by the District with remaining funds provided by the State of South Carolina. Additionally, the City Manager is hereby authorized to execute the attached Service Contract Agreement or on a form to be approved by the City Attorney, between the City of Columbia and Richland County School District One for the implementation of the City's contribution to the JAG-SC Program.
