**911 COMMUNICATIONS CENTER CONSOLIDATION AGREEMENT
RESTATEMENT AND EXTENSION**

WHEREAS the City of Columbia ("City") and Richland County ("County") entered into the 911 Communications Center Consolidation Agreement ("911 Agreement"), dated July 1, 2010, thereafter extending said Agreement in 2022 for additional periods ending on June 30, 2025; and

WHEREAS that 2022 extension of the Agreement expired; and

WHEREAS the City and County desire to restate and extend the term of the Agreement for an additional term ending on June 30, 2026.

NOW THEREFORE, BE IT RESOLVED, in consideration for the mutual undertakings and terms contained herein, the City and County agree as follows:

1. The term of the 911 Agreement, with its subsequent extensions, which are incorporated herein by reference shall be restated and extended for an additional period ending on June 30, 2026.
2. Except as modified herein and restated and extended hereby, the Agreement shall remain in full force and effect.
