## **ORDINANCE NO.: 2018-032**

Amending the City of Columbia Comprehensive Plan 2018 Future Land Use Map to modify Future Land Use Classifications throughout the City of Columbia

WHEREAS, the properties referenced in Attachments A and B were included within Plan Columbia Land Use Plan Putting the Pieces in Place adopted by City Council on February 17, 2015; and,

WHEREAS, the City of Columbia Planning Commission has provided input and recommendations in response to the public input and findings NOW, THEREFORE,

BE IT ORDAINED by the Mayor and City Council of the City of Columbia this 14th day of August, 2018, that the properties referenced in Attachments A and B, included in the Plan Columbia Land Use Plan Putting the Pieces in Place adopted by City Council on February 17, 2015, shall be assigned the designated future land use classifications, and the Future Land Use Map shall be amended accordingly.
