BE IT ORDAINED by the Mayor and City Council of the City of Columbia, South Carolina, 2nd day of June, 2020, that the property described herein is hereby annexed to, incorporated into Plan Columbia Land Use Plan Putting the Pieces Together adopted by Ordinance No.: 2015-014 on February 17, 2015, and becomes a part of the City of Columbia effective immediately. This property shall be assigned interim zoning of General Residential (RG-2), apportioned to City Council District 3, Census Tract 26.03, contains 0.44 acres, and shall be assigned an interim land use classification of Urban Core Residential Small Lot (UCR-1).



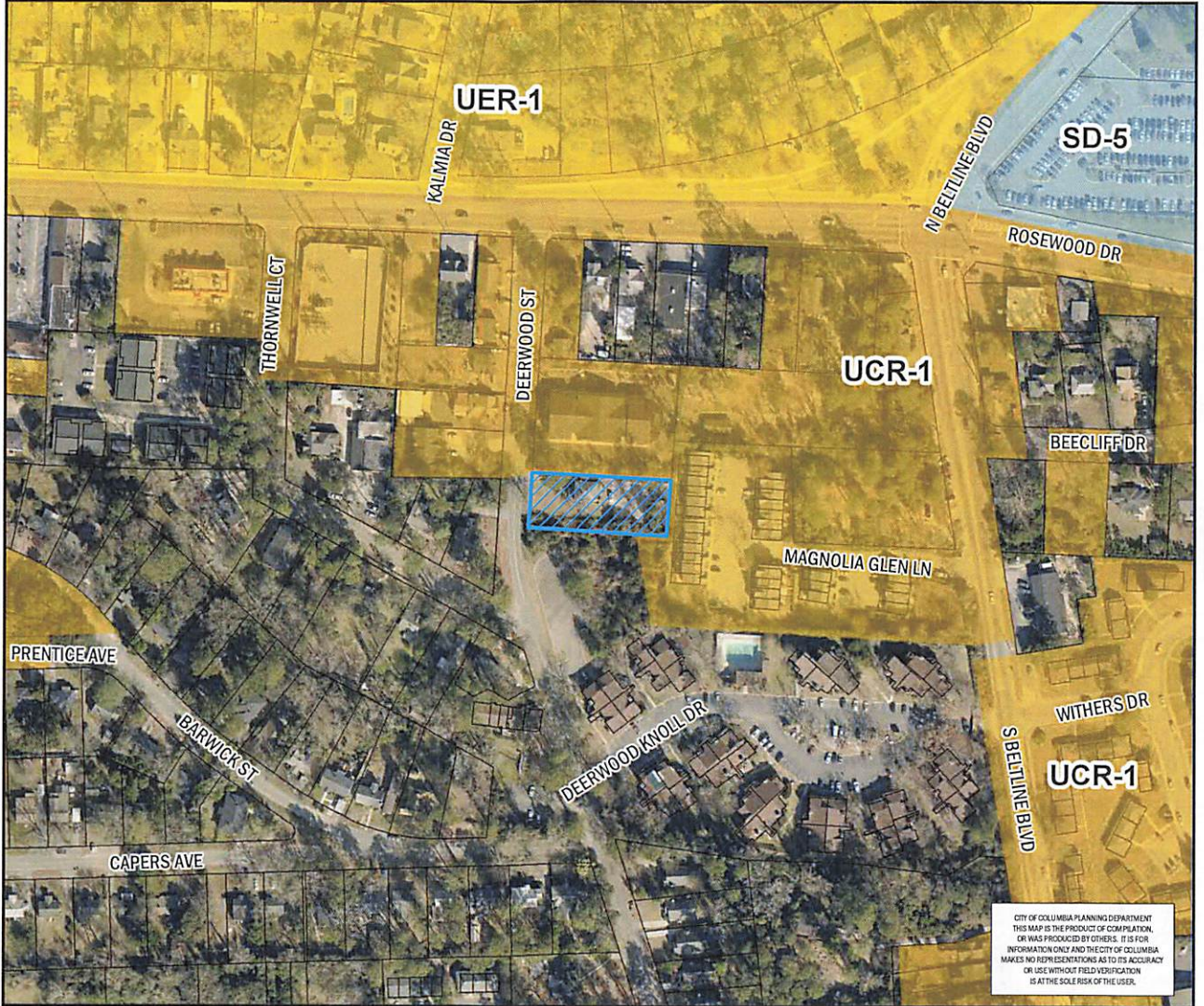

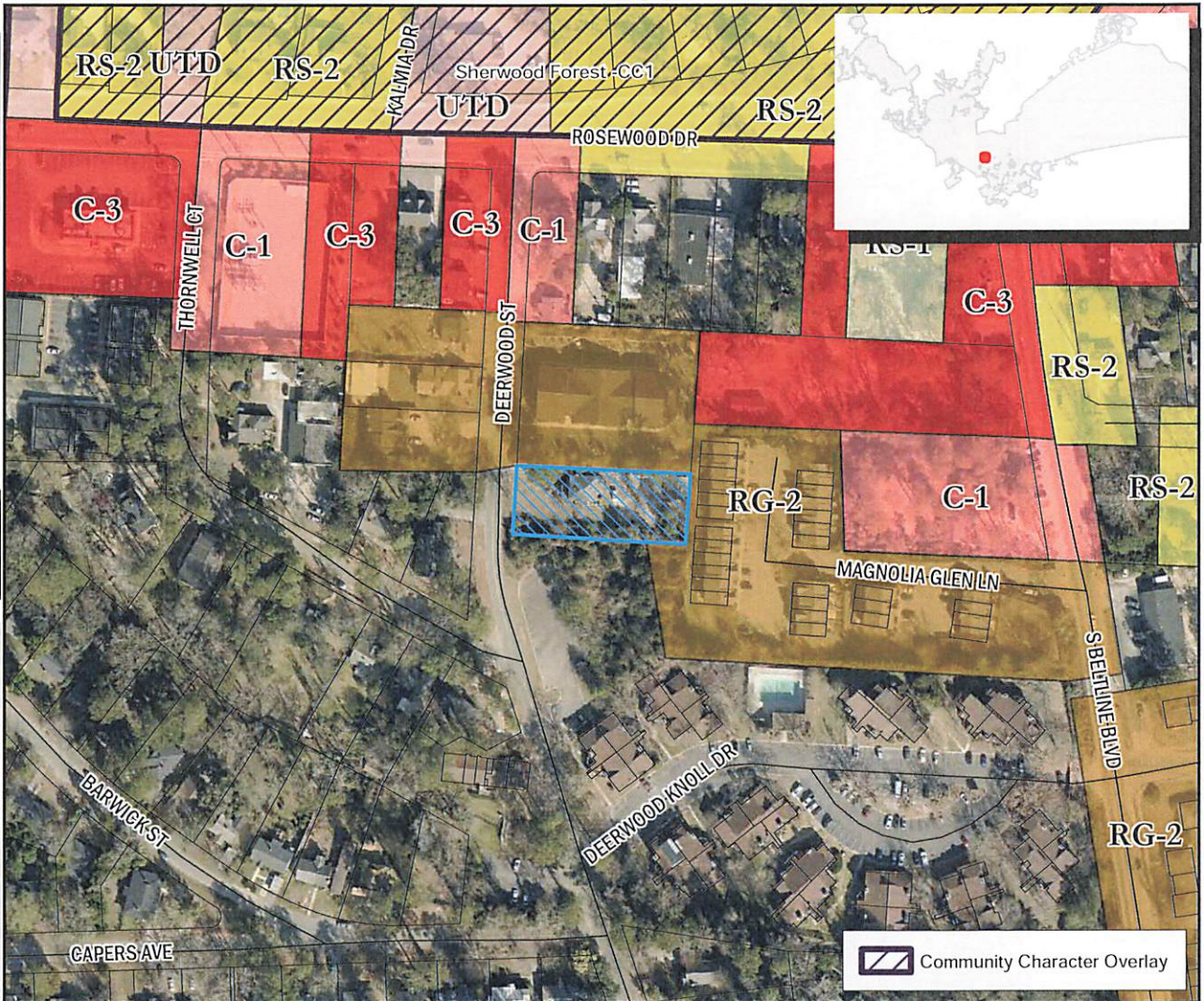
