

**ORDINANCE NO.: 2021-039** 

Authorizing transfer of streets to the South Carolina Department of Transportation identified as Gadsden Street (100' R/W) from Richland Street to Calhoun Street, Richland County TMS#09011-10 & 13; Calhoun Street (100' R/W) from Gadsden Street to Lincoln Street, Richland County TMS#09011-10 & 11; Pendleton Street (100' R/W) from S. Main Street to Sumter Street, Richland County TMS#11304-01 & 08 and TMS#08916-05 & 06; Sumter Street (100' R/W) from Gervais Street to Pendleton Street, Richland County TMS#08916-04, TMS#11401-12, TMS#11304-01 & 02; and Pendleton Street from Assembly Street to Lincoln Street, Richland County TMS#08916-07, 08, 09 & 10; CF#220-610

WHEREAS, the above-referenced streets are City-owned streets in the city limits of Columbia and are proposed to be conveyed to the South Carolina Department of Transportation (also hereinafter referred to as "SCDOT") in exchange for the conveyance of Candi Lane (Secondary Road #S40-2889) and that portion of Park Street from Gervais Street to Pendleton Street; and

WHEREAS, Candi Lane will benefit the City of Columbia by providing access to the Three Rivers Greenway – Saluda Riverwalk, Park Ranger building, parking areas and other amenities in its vicinity and Park Street is being exchanged for a portion of Pendleton Street; and,

WHEREAS, the City's Public Works Director and the Director of Engineering recommend that the City accept the road swap agreement and transfer of the specified portions of the referenced streets to the South Carolina Department of Transportation; NOW, THEREFORE,

BE IT ORDAINED by the Mayor and City Council of the City of Columbia, South Carolina this 18<sup>th</sup> day of May, 2021, for and in consideration of a road swap agreement for conveyance of Candi Lane and that portion of Park Street from Gervais Street to Pendleton Street to the City of Columbia that the City of Columbia transfer the specified portions of the aforesaid streets known as Gadsden Street, Calhoun Street, Pendleton Street, and Sumter Street to the South Carolina Department of Transportation. The City Manager is authorized to sign all documents to facilitate the transfer of specified portions of the aforesaid streets to the South Carolina Department of Transportation.

The referenced portions of Gadsden Street, Calhoun Street, Pendleton Street, and Sumter Street are located in District 2 in downtown Columbia as shown on plats prepared by the City of Columbia, Department of Engineering, and being on file in the office of the Department of Engineering under CF#220-610. Reference is made to the attached Exhibit "A".







Dear Sir:

With reference to improvement by the South Carolina Highway Department of certain streets in the City of Columbia, this is to certify that these streets have a dedicated width of not less than forty (40) feet. The streets referred to are as follows:


> Road 111 - Ott Road, From Rosewood Drive to Wheat Street. Road 95 - Kilbourne Read, From Devine Street to Heyward Street.
> Road 114 - Butler Street, From Milbroad Avenue to Trenholm Road.
> Road 113 - Greenwood Road from Devine Street to Milbrood Avenue. Road 116 - Deveremox Road, From Daly Street to Kilbourne Road. Road 115 - Glemmood Road, From Forest Drive to Trenholm Road. Road 59 - Park Street, From Union Street to Northwood Street. Road 97 - Northwood Street, From Park Street to River Drive. Road 98 - Florence Street From Park Street to River Drive. Road 100-Union Street, From Park Street to Clark Street. Road D1- Deanfort Street, From Park Street to Clark Street. Road 108 - Wheat Street, From Main Street to Barnwell Street. Road 106 - Gadsden Street, From Gervais Street to Richland Street. Road 112 - Sims Avenue, From Devine Street to Millwood Avenue. Road 121 - Daly Street, From Millwood Avenue to Devereaux Road. Road 122 - Michigan Street and Princeton Street, From Daly St. to Deverganx Road. Road 110 - Shandon Street, From Rosewood Drive to Wheat Street.

In the event that it is found necessary to widen the above streets at a later date in connection with the improvements of the same by the South Carolina Highway Department, the City of Columbia will furnish, without cost to the Highway Department, any necessary additional Right of Way widths.

Road 168: Along Lincoln Street One-hundred (100) feet from Laurel Street (Road 157) to Richland Street.

Road 169: Along Hampton Street One-hundred (100) feet from Huger Street (Road 102) northeasterly to Park Street.

Road 170: Along Lady Street One-hundred (100) feet from Huger Street (Road 102) northeasterly to Wayne Street at terminus of present pavement. (Station 10/90).

Road 171: Along Park Street One-hundred (100) feet from Gervais Street (U. S. Route 1), southerly to Senate Street.

Road 172: Along Barnwell Street One-hundred (100) feet from Gervais Street (U. S. Route 1), northerly to Calhoun Street.

Road 173: Along Gregg Street One-hundred (100) feet from Hampton Avenue to Taylor Street.

Road 174: Along Pendleton Street One-hundred (100) feet from South Main Street to Assembly Street.

Road 175: Along College Street One-hundred (100) feet from South Main Street to Assembly Street.

Road 177: Along Sumter Street one-hundred (100) feet from Whaley Street, northerly to Blossom Street.

Road 178: Along Devine Street One-hundred (100) feet from Sumter Street to Marion Street, thence along Marion Street One-hundred (100) feet to Wheat Street (Road 108).


Road 179: Along Henderson Street Seventy (70) feet from Blossom Street to Devine Street, thence along Devine Street Seventy (70) feet fo Blossom Street.

In the event it is ever found necessary to widen the streets (or street) to accommodate future traffic needs such as construction of curb and gutters, storm drainage and sidewalks, such work to be accomplished as a joint undertaking between the Town and the Highway Department, the Town will cooperate in securing any necessary additional width of right of way and bear the expense, if any, in connection therewith.



- Road 162: Along Florence Street from Broad River Road (U. S. Route 76), northeasterly to Earlwood Drive.
- Road 163: Along Beaufort Street from Broad River Road (U. S. Route 76), northeasterly to George Street, thence northwesterly along George Street to Earlwood Drive, thence along Earlwood Drive to Union Street.
- Road 164: Along Sumter Street from Summerville Ave. to Geiger Avenue.
- Road 165: Along Franklin Street from North Main Street (U. S. Route 21), northeasterly to Bull Street.
- Road 166: Along Scott Street from North Main Street (U. S. Route 76), northeasterly to Sumter Street.
- Road 167: Along Laurel Street from Gist Street, northeasterly to Park Street, thence along Park Street to Richland Street.
- Road 168: Along Lincoln Street from Laurel Street (Road 167) to Richland Street.
- Road 169: Along Hampton Street from Huger Street (Road 102) northeasterly to Park Street.
- Road 170: Along Lady Street from Huger Street (Road 102) northeasterly to Wayne Street at end of present pavement.
- Road 171: Along Park Street from Gervais Street (U. S. Route 1), southerly to Senate Street.
- Road 172: Along Barnwell Street from Gervais Street (U. S. Route 1), northerly to Calhoun Street.
- Road 173: Along Gregg Street from Hampton Avenue to Taylor Street.
- Road 174: Along Pendleton Street from South Main Street to Assembly Street.
- Road 175: Along College Street from South Main Street to Assembly Street.
- Road 177: Along Sumter Street from Whaley Street, northerly to Blossom Street.
- Road 178: Along Devine Street from Sumter Street to Marion Street, thence along Marion Street to Wheat Street (Road 108).




