RESOLUTION NO.: R-2021-049

Authorizing acceptance and dedication of street known as Candi Lane (50' R/W) to the City of Columbia from Greystone Boulevard to the Dead-End, Richland County TMS#07211-01, 07215-02, 07208-03 and acceptance and dedication of that portion of Park Street from Gervais Street to Pendleton Street (100' R/W), Richland County TMS#08916-02, 03,07, 08, 09, & 10; CF#220-610

WHEREAS, Candi Lane is identified as South Carolina Department of Transportation (also hereinafter referred to as "SCDOT") Secondary Road #S40-2889 and is located primarily in the City limits of Columbia on the southwestern side of Interstate I-126 extending for 1.24 miles from Greystone Boulevard to its dead-end. Candi Lane will benefit the City of Columbia by providing access to the Three Rivers Greenway–Saluda Riverwalk, Park Ranger building, parking areas and other amenities; and,

WHEREAS, as consideration for the dedication of Candi Lane to the City of Columbia, SCDOT has agreed to accept the following four (4) streets into SCDOT's state road system for maintenance – Gadsden Street from Richland Street to Calhoun Street; Calhoun Street from Gadsden Street to Lincoln Street; Pendleton Street from S. Main Street to Sumter Street and Sumter Street from Gervais Street to Pendleton Street; and,

WHEREAS, that portion of Park Street from Gervais Street to Pendleton Street is currently in SCDOT's state road system and will be exchanged for transfer to the City of that portion of Pendleton Street from Assembly Street to Lincoln Street; and,


WHEREAS, the City's Public Works Director and the Director of Engineering have inspected referenced streets and found that they are in compliance with the City's ordinances and regulations and recommend approval for acceptance. It is also recommended that the City accept and execute the road swap agreements with the SCDOT; NOW, THEREFORE,

BE IT RESOLVED by the Mayor and City Council of the City of Columbia, South Carolina this 4th day of May, 2021, for and in consideration of the mutual benefits to be derived from the road conveyance and transfer under the road swap agreements that the City of Columbia accepts dedication of the aforesaid streets known as Candi Lane and that portion of Park Street from Gervais Street to Pendleton Street from the South Carolina Department of Transportation. The City Manager is authorized to sign all documents to facilitate the transfer of Candi Lane and said portion of Park Street to the City of Columbia.

Candi Lane is located along the southwestern side of Interstate I-126 in District 2 and Park Street is located in the Vista area in District 2 as shown on street plans prepared by the South Carolina Department of Transportation, and being on file in the office of the Department of Engineering under CF#220-610. Reference is made to the attached Exhibit "A".

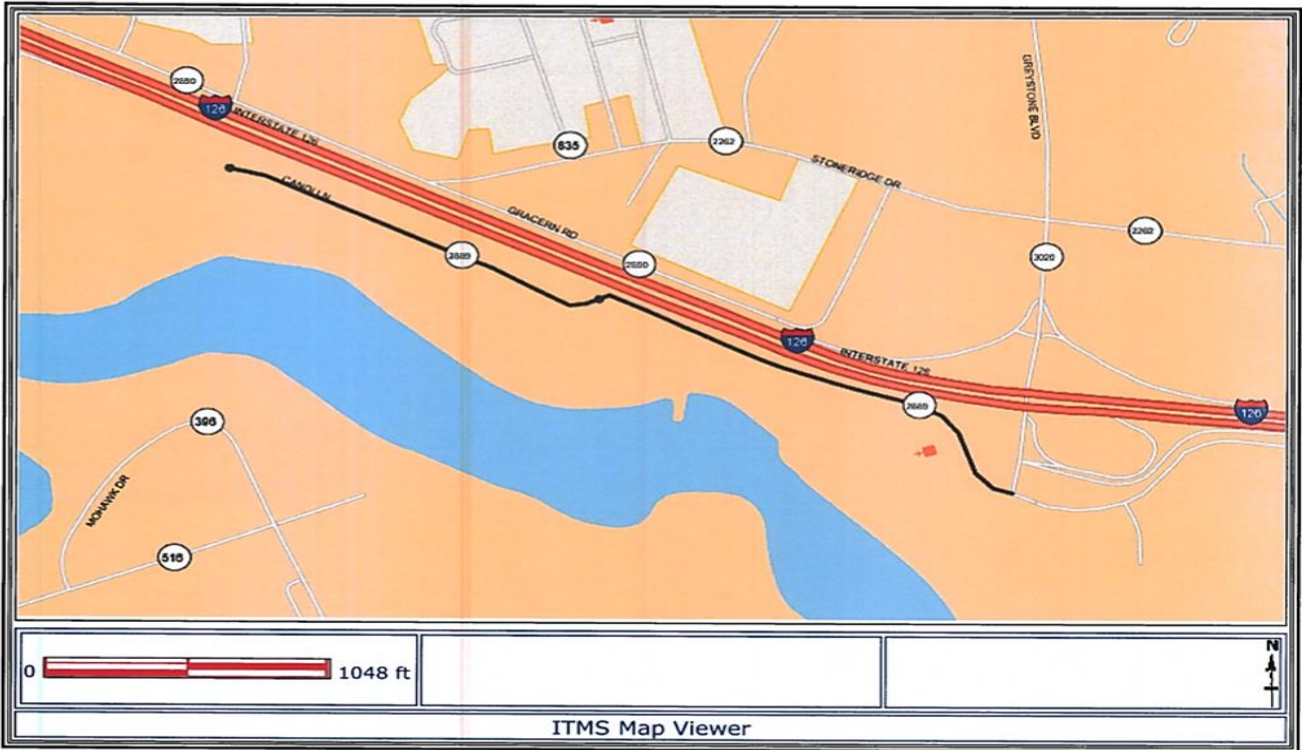
