Authorizing consumption of alcoholic beverages and Main Street Latin Festival

WHEREAS, Coqui Coqui Productions ("Coqui") is sponsoring the Main Street Latin Festival in the 1400 block of Main Street between Washington Street and Hampton Street on Saturday, September 6, 2003 from 12:00 p.m. until 6:00 p.m.; and,

WHEREAS, Coqui has requested permission for the temporary closing and use of the portion of the 1400 block of Main Street between Washington Street and Hampton Street on Saturday, September 6, 2003 from 7:00 a.m. until 9:00 p.m. for staging and preparation of the event; and from 12:00 p.m. until 5:00 p.m. for patrons to consume beer and wine beverages at the event, and for crowd control and overflow; and,

WHEREAS, it has been determined that such an event would be in the public interest; NOW, THEREFORE,

BE IT RESOLVED by the Mayor and Council this 18th day of June, 2003, that the sale of beer and wine beverages is authorized between the hours of 12:00 p.m. and 5:00 p.m.; and,

BE IT FURTHER RESOLVED that all vendors be restricted to stationary location; and,

BE IT FURTHER RESOLVED that only pedestrian traffic will be allowed within the area. All other traffic, including, but not limited to, automobiles, trucks, motorcycles, mopeds, bicycles, skate boards, and horses, except police horses, is prohibited. All pets shall be prohibited. Coolers, glass bottles, breakable glasses and/or cups, large bags and backpacks shall be prohibited; and,

BE IT FURTHER RESOLVED that during the designated time the closed portion of Gadsden Street, with the exception of the parking area and any other areas posted as to not

allow alcoholic beverages, shall be declared to be a Public Park and provisions of Part 2, Article D, Division II, Sections 2-2052 through 2-2054, 1979 Code of Ordinances of the City of Columbia, South Carolina are in effect. Pursuant to Section 2-2047(2)(b), 1979 Code of Ordinances of the City of Columbia, South Carolina, that portion of the 1400 block of Main Street between Washington Street and Hampton Street, with the exception of the parking area and any other areas posted as to not allow alcoholic beverages, is deemed to be the site of a public festival at which alcoholic beverages may be consumed and the prohibition against possession or consumption of alcoholic beverages set forth in Section 2-2047 shall not apply. Possession and consumption of alcoholic beverages shall be permitted only in containers provided by vendors within the areas designated.

PROVIDED, HOWEVER, that no solicitation or transactions be made in violation of Code Section 2-2046, et. seq., 1979 Code of Ordinances of the City of Columbia, South Carolina.
