Authorizing consumption of beer and wine in the 1000 block of Washington Street for outdoor concerts at Kelly's Deli and Pub on Saturday, June 2, 2007

WHEREAS, Kelly's Deli and Pub ("Kelly's") is holding an outdoor concert on Saturday, June 2, 2007 from 10:00 a.m. Saturday, June 2, 2007 until 2:00 a.m., Sunday, June 3, 2007 adjacent to its business in the 1000 block of Washington Street;

WHEREAS, Kelly's has requested permission for the temporary closing and use of the 1000 block of Washington Street adjacent to its building from 9:00 a.m. Saturday, June 2, 2007 until 2:00 a.m. Sunday June 3, 2007 for preparation and staging of the area for an outdoor event to be held between 10:00 a.m. Saturday, June 2, 2007 until 2:00 a.m. Sunday, June 3, 2007, and for patrons to consume alcoholic beverages at the event during the hours of 10:00 a.m. Saturday, June 2, 2007 until 1:30 a.m. Sunday, June 3, 2007; and,

WHEREAS, it has been determined that such an event would be in the public interest; NOW, THEREFORE,

BE IT RESOLVED by the Mayor and Council this 2nd day of May, 2007, that the sale of alcoholic beverages is authorized between the hours of 10:00 a.m. on Saturday, June 2, 2007 and 1:30 a.m. on Sunday, June 3, 2007; and,

BE IT FURTHER RESOLVED that all vendors be restricted to stationary location; and,

BE IT FURTHER RESOLVED that only pedestrian traffic will be allowed within the area. All other traffic, including, but not limited to, automobiles, trucks, motorcycles, mopeds, bicycles, skate boards, and horses, except police horses, is prohibited. All pets, including snakes, shall be prohibited. Coolers, glass bottles, breakable glasses and/or cups, large bags and backpacks shall be prohibited; and,

BE IT FURTHER RESOLVED that during the designated time the closed portion of the

1000 block of Washington Street, with the exception of the parking area and any other areas posted as to not allow alcoholic beverages, shall be declared to be a Public Park and provisions of Chapter 15, Parks and Recreation, Sec. 15-1, 15-2 and 15-3, 1998 Code of Ordinances of the City of Columbia, South Carolina are in effect. Pursuant to Chapter 14, Offenses and Miscellaneous Provisions, Article IV, Offenses Against the Public Peace and Order, Sec. 14-99, 1998 Code of Ordinances of the City of Columbia, South Carolina, between the hours of 10:00 a.m. Saturday, June 2, 2007 and 1:30 a.m. Sunday, June 3, 2007, the 1000 block of Washington Street, with the exception of the parking area and any other areas posted as to not allow alcoholic beverages, is deemed to be the site of a public festival at which alcoholic beverages may be consumed and the prohibition against possession or consumption of alcoholic beverages set forth in Sec. 14-99 shall not apply. Possession and consumption of alcoholic beverages shall be permitted only in containers provided by vendors within the area designated.

PROVIDED, HOWEVER, that no solicitation or transactions be made in violation of Code Sec. 14-32, 1998 Code of Ordinances of the City of Columbia, South Carolina.
