THIS RIGHT OF ENTRY AGREEMENT (the "Agreement") is made by and between the City of Columbia ("Grantor") and The River Alliance ("Grantee").

## WITNESSETH:

WHEREAS, Grantor hereby grants to Grantee its successors or assigns, a Right of Entry as further described herein, together with the right of ingress and egress at all times necessary for the duration of the design, engineering and permitting necessary for construction of Phase II of the Saluda Riverwalk, a component of the Three Rivers Greenway.

This access includes the property, which Grantor owns, situate, lying and being referred to as TMS R09003-02-01 and TMS R07314-02-05 on the Broad River in Columbia, South Carolina. This is in accordance with the illustration attached as Exhibit "A", which will become a part of the City of Columbia's Three Rivers Greenway and complete the Saluda Riverwalk project.

Grantee and its engineers and consultants will enter the property to accomplish the design, engineering and permitting necessary to construct Phase II of the Saluda Riverwalk. This will include but not be limited to: topographical survey; wetland delineation; identification of protected species; permits for wetland or stream impacts; state navigable waterway permit; letter of map revision or conditional letter of map revision; archeological report; and design drawing.

This access will continue in effect for up to twenty-four (24) months from the date of approval.

TO HAVE AND TO HOLD the aforesaid rights to Grantee, its successors and assigns, as aforesaid.
