## LEASE RENEWAL AGREEMENT

LEASE RENEWAL is made and entered into by and between the CITY OF COLUMBIA (hereinafter "Lessor") and BRANCH BANKING AND TRUST COMPANY, a North Carolina banking corporation (hereinafter "Lessee").

## WITNESSETH:

WHEREAS, Lessor and Lessee entered into a certain Lease Renewal dated as of the 26<sup>th</sup> day of October 2016, (collectively the "Lease") for certain demised premises known as 3905 Ensor Avenue (Lutheran Survey Building), in the City of Columbia, County of Richland, State of South Carolina, as more particularly described in the lease: and

WHEREAS, Lessee has elected to extend the Term of the Lease for a period of one (1) year commencing on November 29, 2017 and expiring on November 28, 2018.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto agree as follows.

- 1. Rent for the period of November 29, 2017 through November 28, 2018 shall be Four Hundred and Fifty and No/100 (\$450.00) Dollars per month.
- 2. The aforesaid Lease, a copy of which is attached hereto and incorporated herein by reference thereto, is hereby renewed for a term commencing on November 29, 2017 and terminating at 11:59 p.m. on November 28, 2018.
- This Lease Renewal must not extend beyond November 28, 2018.
- 4. The parties agree to renew the Lease on the same terms and conditions as forth set in the Lease Renewal Agreement dated October 26, 2016.
- 5. With the exception of the term of the Lease as modified herein, the parties shall be bound by all other terms and conditions of the aforesaid Lease as if fully set out herein and except as modified hereby such terms shall be in full force and effect.
